Client approves arrangements and agrees to pay all charges. Client assumes full legal responsibility for passengers and full financial responsibility for losses or damages to vehicle/s caused by client or passengers. Client agrees to pay per vehicle: 1) a \$35 reservation fee if client cancels or a 10% of total amount fee if client cancels within 10 days of P/U date and up to 50% of total reservation charges if cancels within 24hrs of P/U; 2) for any service not specified above including additional time/use of the vehicle in 1 hour minimum increments, parking, tolls, chain/cable service; 3) for broken/missing items at \$15 per glass, \$45 per decanter, **\$500 FOR BROKEN SUNROOF**; 4) **\$25 per hour with two hour minimum for removal of marks, stains, spills, odors, food and litter**; 5) **\$500 for vomiting, \$100 for smoking in vehicle**; 6) vehicle "down-time" required to repair/replace losses/damages at \$90 per hour, \$900 per day. Coastal Breeze is not responsible for: a) articles left in a vehicle; b) illegal or unsafe acts by client or passengers; c) delays due to clients, traffic, weather or mechanical failure. Coastal Breeze may subcontract services and substitute equipment. The driver may immediately terminate the service and the client will pay all charges: 1) **if the driver perceives a threat from the client, passengers, driver or vehicle or an illegal or unsafe act by the client or passengers**; 2) if client's use of the vehicle has or will exceed the agreed drop-off time; 3) for non-payment or other breach of this agreement. Coastal Breeze maintains climate control systems on vehicles and severe temperatures may minimize their effectiveness. Client accepts vehicle/s in good, clean, working order. There is no refund for time/use of vehicle/s. The driver's record of time/use of the vehicle/s will be the authoritative record used for determining charges to the client. Complimentary items/services provided by Coastal Breeze, LLC are not charged and have no value. Client agrees to pay any and all fees required to enforce or collect this agreement. A \$50 fee is charged for returned checks. Client authorizes the issuer of the credit card identified above to pay the amount shown as TOTAL CHARGES and any and all charges granted by this agreement.
